## SCHOLARSHIP

## PROGRAM

The **WASBO Scholarship Program** was established in 1993, to assist WASBO members in furthering their education in the areas of school business management. The scholarship program has two branches as outlined below.

◆ **WASBO-sponsored scholarships for WASBO programs:**

- Funds are raised through the Silent Auction and other activities conducted at the Annual Conference and through the generosity of members and affiliated members.
- Recipients are able to use these scholarships for registration fees for WASBO's courses, workshops and the Annual Conference. Scholarships for lodging and meals are not available unless included in the registration fee.
- Scholarships awarded shall not exceed \$500 per recipient in a single fiscal year.
- Scholarships will be awarded based on priority of financial need, both district and personal. Special consideration will be given to school districts with recent levy failures or other restrictions, and applicants should identify themselves accordingly.

◆ **Affiliate-sponsored scholarships:**

- Scholarship funds may be contributed by affiliate members and may be designated by each affiliate member for a particular purpose or purposes (e.g., college or university courses, registration and room and board for attending the ASBO annual conference, WASBO offerings, or educational charities).
- The size of the award, eligibility requirements, and applicants' qualifications will be determined by the affiliate member. WASBO will develop appropriate guidelines should the affiliate members indicate that WASBO determine any of these particulars,

- The scholarships awarded will be announced at the Annual Conference.
- The WASBO President, with Board approval, may designate the beneficiary or beneficiaries of the D.A. Davidson Presidential Scholarship as well as the authorized use.

### **General Requirements**

1. Each candidate must request an application per instructions on the website or in the Reporter. Information about any scholarship will be available from the WASBO office, website or in the Reporter. Affiliate-sponsored scholarship applications will be due at a deadline, established by the Board and posted on the website or in the Reporter, prior to the Annual Conference. All other scholarships may be submitted throughout the year.
2. WASBO reserves the right not to award a scholarship in any given category in any given year pending quality of the application, availability of funds, etc. The Board reserves the right to limit the number of scholarships awarded to employees of a given district.
3. The WASBO Board of Directors, or a designated subcommittee thereof, will serve as the screening and selection committee.
4. All scholarships will be remitted directly to the institution or organization involved, following verification of enrollment.
5. Scholarships will be awarded without regard to race, creed, color, age, national origin, gender, sexual orientation, marital status, or the presence of any handicap..
6. Current board members are ineligible to apply for and receive scholarships.
